

EPHS Behaviour for Learning Policy Addendum – Jan 2021

Outside of school

- **Walk, cycle or travel in a family car where possible** - For more details click here: [TfL travel advice for children & Parents/Carers](#)
- If you have to travel on public transport, **wear a mask** and socially distance as much as possible
- All students are expected to attend in **full school uniform**
- Students are to **enter through the Westlea Road at the beginning of the school day and exit via Vicarage Lane (South Park exit)** at the end of their school day
- The temperature of each individual will be taken prior to admission being granted
- Consequences to any inappropriate behaviour online will be considered using the guidance outlined in the Student ICT Acceptable Use Agreement as well as Appendix 4 of the schools Behaviour for Learning Policy*
- **Maintain social distancing outside of school** and avoid congregating in large groups of more than 6

In lessons

- **Students are not to enter any other classroom** other than the one outlined on their timetable. This is to include any lessons that are being delivered remotely*
- Students are to **enter and leave classrooms only when authorised** by a staff member. Doors are to remain open
- **Clean hands** using sanitiser on arrival to school and before leaving a classroom
- Students are expected to **adhere to the seating plans** and must remain in their allocated seats for the duration of the day, maintaining the required 2m social distance. Staff may request for students to move when deemed appropriate. e.g. support/call-in/call-out
- **Any masks worn by students must be plain coloured/geometric patterns.** Masks must not display pictures, or any imagery that may be deemed offensive
- **Do not share equipment, drink bottles or food**
- Use a tissue or elbow to cough or sneeze and use bins for tissue waste ('catch it, bin it, kill it')
- Inform staff if you are experiencing COVID-19 symptoms
- **Do not stigmatize your peers** or tease anyone about being sick; remember that the virus doesn't follow geographical boundaries, ethnicities, age, ability or gender

Movement around school site

- Students are required to move quietly, safely and sensibly as they move along corridors and around the site including **observing the one-way systems** where applicable
- Students will **walk on the left** in the corridors and stairways
- Students **must observe the social distancing markers** around school site, including when queuing
- **Toilet capacity limits must be observed** at all times
- **Wash hands frequently** with soap and water for at least 20 seconds
- Students must stay in allocated areas during any social time when applicable
- In the event of inclement weather, students are expected to attend an allocated classroom
- Students that use the field/basketball court are only permitted to play **non-contact sports** and must adhere to social distancing boundaries

Students who fail to adhere to social distancing measures

As our school community adapts to social distancing measures put in place to keep us all safe, there will be moments when students forget to adhere to all the guidelines and transgressions are accidentally made. In such circumstances, students will not be sanctioned, but pupils will be reminded of the guidelines. However, **any student that deliberately or persistently fails to observe the requirements set out above, resulting in a heightened risk to the health and welfare of other members of the community, will face sanctions in line with the school's policy on physical assaults.** All of the above requirements will be adjusted where appropriate. In particular, the school will continue to meet its responsibilities under the Equality Act 2010. Risk assessments for those children subject to EHCPs are already being carried out. Adjustments may also be made for pandemic related reasons, recognising the unique pressures that some students and families have experienced. Parents/Carers are encouraged to inform the school wherever they consider it may be difficult for an individual student to meet these requirements.

*This includes, but is not limited to, inappropriate communication, disruption to remote lessons and cyberbullying. Students demonstrating any of the above actions may be issued with a Fixed Term Exclusion.
